## Pendletonians Appreciate Friends' Gifts From the Heart

Donors gave with their hearts at a record level to the Pendleton Foundation Trust last year. Contributions totaled \$44,600.56.

They sent money to honor their friends and family "just because" or for special reasons, as well as to remember them with memorials and bequests when they died. They found personal reasons to contribute to the Trust fund.

Recently, several citizens donated money to the Foundation to use to help the Pendleton schools. P.F.T has made it possible for the local schools to keep up with modern technology in the classrooms and provide equipment and site improvements for athletics.

Pendleton Foundation Trust has no revenue except for the contributions it receives from the community. It has served the community for 86 years. The trust fund has grown to over five million dollars and has given back more than three and a half million dollars to the community.

The Foundation has invested the money it has received from general donations, memorials, and bequests of former friends of Pendleton. A percentage of the interest received from these accounts is spent annually for local grants. This year, PFT will return almost \$200,000 to the community.

All of this generosity makes it possible for PFT to return larger amounts to the community to make things happen here. It's a wonderful winwin situation because it helps make Pendleton such a special place to live.

## WHERE ARE THEY NOW? Former Scholarship Winner Katie Berry

ine years ago, Pendleton Foundation Trust awarded the first Fisk Scholarship to a deserving PHS graduate. The Foundation board wondered what the former scholarship winners were doing now. So, we are in the process of answering that question.

In our winter newsletter, a follow up on 2009 recipient, Kelli McBee was posted. In this edition, Katherine "Katie" Barry is featured. She received the 2007 Fisk scholarship as well as the Alan Wyland Memorial Scholarship. Katie's musical talent helped her win the Wyland Award.

Following graduation from PHS, Katie attended the college of William and Mary in Williamsburg, VA. She



majored in History and Anthropology, graduating with a B.A. in 2012. While there, she sang in the William and Mary choir for four years. This included giving four concerts yearly. In addition, Katie continued playing the piano and organ.

She was a member of the National Society of Collegiate Scholars and Peer Advising Program, served as a tour guide and proctor for the Wren Building, the oldest academic building still in use in the US - and participated in the 2009 Colonial Williamsburg Archaeology Field Ŝchool.

For the last two years, Katie has worked as a research library aid and analyst for Tamastslikt Cultural Institute in Mission, processing an anthropological collection on loan to the library and archives and analyzing data for the CTUIR Human Resources Consortium.

She spent last summer with the University of Oregon's Northern Great Basin Prehistory Project Archaeological Field School.

She recently accepted a position as Anne Ray intern for advanced research in Santa Fe, New Mexico. During the nine months that she is there she will conduct research and assist with collections management and educational programming at SAR's Indian Arts Research Center. Upon further narrowing her research focus, Katie plans to pursue an advanced degree in Museum Studies or Anthropology.

## **PHS Organizes First Robotics Club**

ith start-up funds from the Pendleton Foundation Trust, Pendleton High School was able to have its first ever Robotics Club. Funding provided robotics kits, spare parts, computers, and programming software to make the season a success.

Students stretched themselves to learn engineering and design principles for building the robots, as well as working to master C Programming language to make the robots operate autonomously and with joystick controls.

They were able to field three teams and attend two qualifying tournaments, first in The Dalles and second in Hermiston. Students walked away from the competitions with a huge sense of accomplishment. Ideas are already in the works for the next season.

Robotics will continue to be offered as a competitive sport at PHS, and next year they are also adding robotics as a class for any students to try within the school day. Classes like this are critical for creating future problem solvers and engineers. Matthew Campbell is the Robotics Club advisor, and a Pendleton High School teacher.
